



## **Dealer Booth – Foreign Postal Administration & Dealers**

Terms & Conditions for Stalls booking by Foreign Postal Organizations & Dealers –

1. All Foreign Dealers will be governed by the Laws of India.
2. Dealers may please note that as per prevalent Indian Laws – Custom Duty and GST is levied on all trade merchandise including Stamps & philatelic material at the time of entry of such goods in the country. The exact rates and tariffs applicable may be obtained by the Dealer.
3. Philatelic Material which is over 99 years old, are governed by the Law under the regulatory authority of Archeological Survey of India (ASI) and no dealer shall bring in or trade in such items without obtaining such License / permission from ASI
4. The Stall Holders General Terms & Conditions will apply, which are also available at [www.inpex2019.com](http://www.inpex2019.com)
5. Goods will be sold in Indian Rupees (INR) at applicable conversion rates
6. Dealers may require the services of a Customs registered Clearing Agent for payment of import duties, GST and other charges

### **Stall Charges:**

Foreign Postal Authorities, Foreign Dealers etc. may be offered the specified Standard / Premium Stall Nos. and Rates in US \$ is given below :

- Standard 4 sq. meter - US \$ 525
- Premium 4 sq. meter - US \$ 625
- Standard 6 sq. meter - US \$ 625
- Premium 6 sq. meter - US \$ 785
- Premium 8 sq. meter - US \$ 950

Note : All interbank charges must be paid by the dealer. We must receive the payment in full amount. We shall pay Indian bank charges.
