Terms & Conditions for Stall Holders

1. Request for booking of Dealer Stalls must be made through online Stall Booking System.
2. Online Booking of Stalls will start soon.
3. Booking of a stall shall be made online on first come first served basis, and will be blocked for an initial period of 7 days. Once payment of full amount (including GST) is received by Our Treasurer and confirmed with the bank, a confirmation of payment received will be sent and the booking confirmation, subject to the realisation of the advance amount in any of the prescribed Payment mode given below.
4. Full Advance amount: An Advance Booking amount as specified against each stall rate chart should be paid by the Stall Booking Person. The Advance Booking amount is Non Refundable. No interest will be payable on the said booking advance or total amount paid.
5. GST Invoice will be raised periodically, depending upon the date of receipt of the Total amount after adjusting the advance amount paid. The applicable GST rate of 18%, Invoicing details and other details have been based on legal advice received.

6. Payment Mode and instructions :

a) Mode of Payment :

- i) By Bank Transfer / RTGS / UTR under reference and advice to PCI
- ii) By Demand Draft or Cheque payable at par, crossed in favour of “PHILATELIC CONGRESS OF INDIA”, payable at Mumbai.
- iii) NO CASH PAYMENT IS ACCEPTED

b) All payments should be made by Bank Draft drawn in favour of ‘**Philatelic Congress of India**’ payable at Mumbai. (Cash payment will not be accepted).

8. If payment is not received by the Treasurer by the due date, the booking will be cancelled/released and same will be further made available for booking by any other person.

9. Dealer Stalls are allotted at the sole discretion of the Organizers.

10. The Stall Layout Floor Plan is Not to Scale and a representative Plan only and may differ with the actual final layout.
11. All efforts will be made to allot the chosen stall, however, Choice of selection is not a guarantee for allotment of that particular stall
12. Stall charges are payable in advance and booking is confirmed only on receipt of full payment, subject to clauses and the terms and conditions laid herein.
13. Philatelic: Selling of fakes and modern fantasy is prohibited. Strict action will be taken against those found doing so including but not limited to asking the participant to immediately vacate the premises without any refund if applicable or calling the authorities and handing over the participant along with the fake material.
14. Lunch and Water coupons will be provided Complimentary with each stall, without any charge by the Organizer, at the time of registration at the venue. Each stallholder will be responsible for the same. Lost, misplaced, expired or forgotten coupons will not be reissued.
The Coupons are non-refundable, non-exchangeable and are only valid on the date printed on them.
15. Each 4 sq mtr are stall includes 2 tables, 2 chairs, 1 power socket and 2 spotlights.
16. A limited number of table-top frames will be made available to Stall Holders from the INPEX Office. The Stall Holder has to go to the said counter in person and pay Rs.4000 that includes a refundable deposit of Rs 3000/- for each table-top frame and a rent of Rs 1000 for all 5 days.
17. A limited number of table cloths will be made available to Stall Holders from the INPEX Office. The Stall Holder has to go to the said counter in person and pay Rs.400 that includes a refundable deposit of Rs 300/- for each frame and a rent of Rs 100 for all 5 days.
18. The deposit amount for the table-top frames and the tablecloths will be refunded at the end of the show on 22-12-19 after the table top frame/tablecloth has been returned at the said counter in proper order. The frames are the property of the Mumbai Coin Society and their decision in any matter concerning the frames is final and binding on the Booth Holder.
19. Extra furniture, Table Cloth, if required by any stall holder, will need to be arranged by the Stall Holder with the Stall Contractor, at an extra cost, subject to availability at the Venue. A Fixed Rate Chart for the same will be available with the Stall Contractor.

21. Rights of admission are reserved
22. Every stallholder is required to provide an invoice under the GST Act 2017. Each stall holder is personally responsible to comply with all applicable government norms, rules and regulations, the organizer will not be responsible for any action or liability arising out of the stallholder's failure to do so.
23. Stalls cannot be transferred or sub-let under any circumstances.

24. LIABILITY - Disclaimer

- i) The Stall Holder will be fully responsible for the safety and security of the stalls and materials/goods therein. Though every possible care will be taken of the exhibits/stock of goods, no liability/responsibility shall be attached either to Philatelic Congress of India or the organizers of the Exhibition, or to members of the Organizing Committee or its employees or Voluntary Associates or Contractors for any loss or damage to the exhibits arising from any cause or reason whatsoever.
 - ii) For all disputes arising in respect of the exhibition, the decision of the Organizing Committee shall be final and for all legal matters the Mumbai Courts will have jurisdiction.
 - iii) Force Majeur : In case of any local emergency, strike, closure or unrest, natural disaster etc. the Organisers will not be held responsible for any loss of business or opportunity or Number of Visitors etc. or any consequential losses due to any reason and/or closure or stoppage of the event or show including the Dealer Stalls and/or Auction Slots etc.
